

Midburn Participation Terms and Regulations - Burn to Basics 2024

1. Introduction

- 1.1. The following conditions constitute a legal agreement for all intents and purposes between the Midburn Association RA 580567600 (the **"Event Organizer"**) and/or any of its producers (the association and/or the producer will be referred to jointly and separate as: the **"organizers"**), and between each and every one of the profile owners registered on the association's website and/or ticket purchasers with regard to their participation in any event organized by the association (**"event/s"**). You are requested to **carefully read what is stated in these terms. If you do not agree to any condition, you are required to withstand participation in the event.**
- 1.2. Any reference herein to "participant(s)", whether singular or plural, also includes attendees accompanying the ticket purchaser, such as children, minors under their care and/or anyone else who accompanies the ticket purchaser and for whom the ticket purchaser assumes full responsibility. This agreement supersedes any content presented on the association website, which might contradict the terms and conditions outlined in the clauses of this document.
- 1.3. **Wherever "the event" or "the city" is mentioned is also in reference to the period of the initial establishment of the city and its dismantlement.**
- 1.4. **Purchasing a ticket to the event constitutes absolute and unconditional agreement to everything stated in these conditions.**

2. Definition of a Midburn Event

Periodically, thousands of people gather in the Negev desert to create Midburn City, dedicated to community, art, self-expression, and self-reliance. This melting pot of participation and creativity is open to all. Midburn is a special and unique project for the Midburn community and the global Burning Man community, modeled after the Burning Man event in Nevada, USA. It involves setting up a temporary city in the desert for several days, after which the city is dismantled, and the site is cleared of all material not belonging to the natural surroundings, returning the area to its natural state, as prior to the event.

The temporary city is based on the content and activities of the community members, guided by ten principles that lead and direct it. Everything that happens there is the result of your and your participating friends' creation, building, activities, and participation.

It should be emphasized that the organizers are not responsible for the programs/contents established at the event, even if they have approved their creation.

As in any other city, the temporary city has a system of essential infrastructure and community services, including city planning, emergency and medical services, safety and security departments, sanitation, etc. These are established and run mainly by volunteers to provide adequate essential services to support the residents of the temporary city. **The rest is up to the participants.**

3. The Ten Principles Guiding Personal Conduct at The Event

It is mandatory to read and familiarize yourself with the [Ten Principles](#) of Midburn prior to attending the event. It is also mandatory for all participants to conduct themselves in accordance with the Ten Principles for the entire time they are present in The event complex, including the full duration of the event and during any other activity relating to the event, such as construction, organization, and disassembly, in the case that you take part in these activities.

4. Personal Responsibility

- 4.1. Keep safe! - First and foremost - take care of yourself! Pay attention to your needs and to the demands of your body, maintain your safety and the safety of those around you. Pay attention to anything that could endanger your safety and the safety of others.
- 4.2. Keep yourself healthy! - By participating in the event, you hereby confirm and declare that you are healthy and able to participate in The Event and in any activity it entails, and that you are not forbidden by any doctor/physician to participate in the event or in any kind of activity that takes place at the event. If at the time of the event you do not have a level of health that allows you to safely participate, you are obligated not to attend the event.

- 4.3. Watch your kids! - Children under the age of 18 are welcome to participate in events open to minors with the consent of both parents (regardless of marital status). Throughout the event, a child must be accompanied by a parent at all times. It is your personal responsibility to ensure your children's safety during the event. Be mindful and responsible for the activities and content your children are exposed to throughout the event. Serving alcohol to individuals under 18 is prohibited by law. For clarity, these participation terms fully apply to your children, and by bringing them to the event, you also accept these terms on their behalf as their natural guardian. You confirm that both parents have given their consent for the child's participation.
- 4.4. Protect the environment! - You are entirely responsible for maintaining the cleanliness of your surroundings throughout the event, especially at its conclusion. Ensure you remove all equipment, materials, or waste you brought or accumulated during the event, leaving no trace of your presence. Part of your participation involves contributing your time to the event's cleanliness during and at its conclusion, reinforcing our commitment to leaving no trace and protecting the natural environment.
- 4.5. Look after your belongings! - You are personally and solely responsible for all equipment and property that you bring with you to the event. We recommend marking your belongings with your name, email, phone number and camp location, as well as keeping any valuable items under supervision or in a safe location. **The organizers will not bear liability for any loss, theft, or damage of your belongings.**

5. Ticket Purchase and Transaction Cancellation

- 5.1. **The ticket is personal - you cannot enter the event with a ticket under someone else's name.**
- 5.2. Payment for the ticket will be made by credit card only. It is clarified that the payment itself is conducted through an external clearing system operated by an external company (hereinafter: "**the clearing company**"). It is clarified that any purchase made through the clearing company will be subject to the terms of use of the clearing company's website. The association will make efforts to contract with a clearing company that has authorization for database management and security as required by the Privacy Protection Law 5711, 1981, and operates according to stringent security standards.

- 5.3. **Cancellation of a transaction**, in accordance with the Consumer Protection (Cancellation of a Transaction) Regulations, 2010, will be possible on the ticket sales site within 14 days from the date of transaction, provided that the cancellation is made no later than 7 business days before the event date. It is clarified and agreed that for the purpose of this clause, the event date is defined as the date of commencement of the event's setup on site, namely – **June 5th, 2024 (hereinafter: "the Event Start Date")**. After the cancellation of the transaction by the purchaser as stated above, the purchaser will be entitled to a monetary refund in accordance with the actual price paid, minus cancellation fees amounting to 5% of the transaction price (hereinafter: "Basic Cancellation Fees"). The purchaser and/or anyone on their behalf will have no claim against the association regarding the mentioned deduction.
- 5.4. **Cancellation of a transaction due to military reserve duty call-up by order 8** - will be possible subject to approval of the cancellation request by a special committee on the matter. Please send the cancellation request along with a copy of the "order 8" dated for the event date to the email - support@midburn.org. Subject of the inquiry: Name of the inquirer, ID number, "Request for transaction cancellation due to order 8". After the cancellation of the transaction as stated above, the purchaser will be entitled to a monetary refund in accordance with the actual price paid, minus only the Basic Cancellation Fees. The purchaser and/or anyone on their behalf will have no claim against the association regarding the mentioned deduction.
- 5.5. **Cancellation of a transaction not within the framework of the Consumer Protection Regulations** (i.e. after 14 days from the date of the transaction) - It is clarified and agreed that in any case of transaction cancellation not within the scope detailed in clause 5.3 above, the purchaser will be entitled to a monetary refund minus cancellation fees and participation fees in the event production costs that have been reduced according to the dates and percentages detailed below:
- 5.5.1. In the event the purchaser requests to cancel the transaction by **May 16th, 2024 at midnight (IL time)**, the purchaser will be entitled to a monetary refund in accordance with the actual price paid, **minus cancellation fees amounting to 10% (10 percent)** of the transaction price. The purchaser and/or anyone on their behalf will have no claim against the association regarding the mentioned deduction.

5.5.2. In the event the purchaser requests to cancel the transaction from **May 17th, 2024 onward**, the purchaser will be entitled to a monetary refund in accordance with the actual price paid, **minus cancellation fees listed under clause 5.6 below**, in accordance with the date of the cancellation request made by the user (as detailed in clause 5.6 below).

5.6. Cancellation Fees in case the event is canceled:

5.6.1. **If the event is canceled for any reason, up until midnight on June 4th, 2024**, the purchaser will be entitled to a monetary refund minus cancellation fees and participation fees in the event production costs that have been reduced by a total of 25% (twenty-five percent) of the transaction price, and the purchaser and/or anyone on their behalf will have no claim against the association regarding the mentioned deduction.

5.6.2. **If the event is canceled for any reason, in the period between June 5th, 2024 and midnight on June 10th, 2024**, the purchaser will be entitled to a monetary refund minus cancellation fees and participation fees in the event production costs that have been reduced, in a total amount of – 50% (fifty percent) of the transaction price. The purchaser and/or anyone on their behalf will have no claim against the association regarding the mentioned deduction.

5.6.3. **If the event is canceled from June 11th, 2024 onwards**, and/or is stopped, for any reason, after it has started, the purchaser is not entitled to any refund. The purchaser and/or anyone on their behalf will have no claim against the association regarding this.

5.7. For the avoidance of doubt, the site administrators and/or the association will not be responsible for any direct or indirect, financial or other damage, caused to the purchaser as a result of purchasing the tickets on the site and/or as a result of event cancellation or postponement, and any reliance on the holding of the events on the planned dates is the sole responsibility of the purchaser.

6. Entering and Exiting The Event

Upon your arrival at the event, it's likely you'll encounter the gate volunteers ("gaters") who will assist you in redeeming the ticket you possess and facilitate your entrance into the event.

- 6.1. Participant entry to the event will be enabled from the moment the gates open, as will be announced.
- 6.2. Early entry into the event will be permitted for authorized participants such as: the production team, the DPW (Department of Public Projects - Mapatz) team, those involved in setting up theme camps, art installation creators, various volunteers, and authorized suppliers, whose early entry has been pre-approved by the production team and whose details have been communicated to the ticket and gate departments. Early entry approval will be contingent on complying with the ticket and gate departments' guidelines.
- 6.3. **Entry is conditional upon presenting a personal entry ticket, participant identification via an ID document, and matching the ID details with those of the ticket purchaser. Without matching these details, entry will not be permitted.**
- 6.4. **What is prohibited from being brought into the event?**
 - 6.4.1. Animals – It is strictly prohibited to bring animals of any kind to the event (including pets), except for guide dogs for the blind.
 - 6.4.2. It is strictly prohibited to bring any type of material that is dangerous, toxic, harmful, or prohibited by law.
 - 6.4.3. Any weapons – Bringing firearms and/or cold weapons into the event premises is strictly prohibited. Note, the prohibition on weapons also applies to licensed firearm holders. There will not be a weapon deposit station at the event.
 - 6.4.4. Drugs – It is strictly prohibited to bring any form/type of illegal drug(s) into the Temporary City.
 - 6.4.5. It is strictly prohibited to bring any item/property/material which might be prohibited by regulatory authorities.
- 6.5. **Consent to Inspection Upon Entry** - The organizers and/or the Israeli Police reserve the right to inspect your belongings and/or your vehicle upon arrival, to ensure you are not carrying any prohibited items according to the law or these terms, and to verify that all attendees have a valid entry ticket. You are obliged to cooperate with the said authorities.

Non-cooperation with such an inspection could result in denial of entry into the event.

- 6.6. **Wearing the Midburn identification wristband** - Upon entry, gate volunteers will place a wristband on you. Children under 18 (in events where their participation is permitted) will receive a distinctively colored wristband to differentiate them from other participants, among other things, to facilitate the enforcement of alcohol prohibition to minors. All participants are required to wear their wristband throughout the event.

Participants caught without a wristband will be immediately expelled from the event.

6.7. **Movement and Location Restrictions**

6.7.1. It is strictly forbidden to park vehicles, including caravans, or to set up camping outside designated areas.

6.7.2. For your information, the movement of vehicles (except for authorized vehicles) is prohibited in the territory of The Temporary City. Therefore, if your vehicle is allotted parking in the temporary city area, you will not be allowed to move it until the end of the event.

- 6.8. **Accessibility for participants with disabilities** - people with disabilities are invited to participate in and attend the event. The organizers will strive to provide the maximum possible access for disabled participants, considering the physical conditions, and subject to the provisions of the law.

6.9. **Rules for Exiting the Event:**

6.9.1. For your information, it is absolutely forbidden to enter or exit The Temporary City with a vehicle for the purpose of loading and removing equipment before the end of The Event. If necessary, you must coordinate approved entry and exit with the organizers and follow the instructions given. There is no requirement for the organizers to provide this type of approval.

6.9.2. Leaving The Event area will only be possible via the exit gate of the city. Please note that if you leave The Temporary City and want to return, you may have to wait in the entry line and re-enter the exact

same way you entered the first time. (This includes presenting your ticket, displaying your bracelet, showing ID and approving inspection for prohibited items).

7. Rules of Conduct at The Event

- 7.1. **Inclusion and tolerance** - radical self-expression stems from the uniqueness of the individual. You may determine the characteristics of your own uniqueness. However, to allow other participants to fully experience and enjoy the event you must respect their rights and freedoms with inclusion and tolerance.
- 7.2. **Zero tolerance for violence** - the organizers of the event advocate a policy of zero tolerance towards violence, whether physical, verbal, or behavioural. If you are harmed by a participant in the event, it is your responsibility to complain to the local authorities (i.e., police).
- 7.3. **Radical self-expression** - it is important that you know some of the participants at the event may behave differently or dress in another way than usual, corresponding with each person's individual self-expression. This self-expression may include among other things partial or full nudity. By signing these Terms and Conditions you are confirming that you choose to participate in the Midburn Event wilfully and knowingly.
- 7.4. **Sexuality, expression and maintaining boundaries** - radical self-expression, whether related to extrovert sexuality e.g., nudity, or partial nudity etc., must not be viewed as an acceptance or invitation for physical contact or any other offensive sexual behavior. Any form of sexual harassment that violates personal dignity, freedom, privacy, and equality between the sexes, is against the association's policy and is strictly prohibited by the guidelines of the association. **It will not be tolerated in the Temporary City.** If you are harassed/harmed by a participant at the event, you are encouraged to report it to the authorities, and inform the person in charge of the Midburn safe space via the following email address: safespace@midburn.org. Any such behaviour will be handled by the association in accordance with its' procedures for handling sexual harassment. These procedures are a binding part of the event's participation terms and conditions. By participating in the event, you are also subject to the Israeli Law for the Prevention of Sexual Harassment. Sexual harassment is a criminal act with grounds for criminal prosecution and damages, and any participant suspected of such conduct will be prosecuted accordingly.

- 7.5. Prohibited activity** - commercial and political activity of any kind, including the distribution of ideological and advertising materials, waving flags, and placing signs of commercial entities, parties and organizations operating with the aim of influencing and recruiting supporters, is absolutely prohibited.
 - 7.6. Rangers** - The Temporary City will have teams of Rangers. The Rangers are volunteers who are trained to mediate and help solve conflicts that might arise between event participants. The Rangers also help maintain security, peace, and general quality of experience at the event. The Rangers are not a function of the national law enforcement authorities and they do not directly intervene in circumstances that constitute violations of the law. The Rangers patrol the city 24 hours a day and are recognized by a khaki-coloured vest with the Rangers patch. You are requested to listen to and obey their instructions.
 - 7.7. Maintaining law and order** - The event takes place in the State of Israel and therefore the laws of Israel fully apply to you during the entire event. It is your responsibility to uphold the law and civic order and observe the directions given by authorities or the organizers of the event. Failure to comply with the directions of the security forces and/or the organizers may cause your expulsion from the event.
- 8. Photography and Documentation (Stills and Video)**

 - 8.1. Photography at the Event** - as a rule, the event is a space that allows the participant to behave and express himself in a unique way. In order not to harm the experiences and privacy of the participants, we recommend that you leave cameras in a safe place and experience the event directly and not through the camera's lens.
 - 8.2. Rules of Photography**- since photography is sometimes an integral part of the experience of many of the participants, and in order to document the event while allowing all participants the freedom to express themselves without fear, photography at the event is subject to the rules detailed in this section (hereinafter: "Photography Rules") and this in addition to the provisions of any national law:

 - 8.2.1.** Use of cameras outside your camp area is strictly prohibited.
 - 8.2.2.** Photography will be for the personal use of the photographer and the photographed person. Photography for any other purpose is strictly prohibited.

8.2.3. Do not photograph participants without their permission, in nudity, or in a way that infringes on their privacy.

8.2.4. It is prohibited to publish or distribute photos of any participant in which the person photographed can be identified, in any way, without their permission. This includes all advertising, media, websites, and social media channels.

8.3. Authorized Photographers at the Event - during the event photos may be taken by authorized photographers, who wear a special identification badge. These photographers will be trained and approved by the Media Department of the Association and will strive to avoid harming the privacy of participants and the nature of the event while taking pictures and publishing them. Different rules may apply to authorized Midburn event photographers, who will act in compliance with the rules and regulations which are issued to them, and they will not be able to post pictures without the explicit permission of the subject.

8.4. As a participant in the event you hereby authorize the Midburn Association to use photos of you, taken by authorized photographers, in order to promote the goals of the association, including use in the website and social networks. However, if you see a picture of you which you think violates your privacy, please contact us and we will remove it.

If you are either a journalist, artistic photographer, a documentarist, or if you want to take photos for publishing in public for any reason and/or if you wish to film using drones during the event, or if you would like to volunteer to be a photographer for the production of the event, you may apply for approval by contacting the Media Department via e-mail at gallery@midburn.org.

8.5. Violating the Photography Rules - the Rules of Photography are a mandatory condition for your participation in the event and with your consent to these regulations you undertake to meet them without reservation. Violating any of the Rules of Photography is against the community spirit and may greatly harm the event, the organizers, and other participants. Therefore, the association will take any action necessary to prevent such violations.

8.6. Agreed compensation for publishing images contrary to the "Rules of Photography" - be aware that in the case where you will advertise, publish or show on internet web sites, social networks or any social media, images which were taken against the Rules of Photography, you may be sued for

compensation by the organizers of the event and by any other party who might be harmed by the images.

In view of your knowledge and understanding of the damage that you may cause to the organizers of the event, by violating the Rules of Photography, and above all by publishing images in contrary to these agreed rules, in particular images that are offensive and/or revealing and/or infringe on privacy, you hereby declare and commit to the organizers of the event that **you will compensate them for any damages they may incur, with a sum agreed upon beforehand of 50,000 New Israeli Shekels** for each image published. You confirm that this amount is reasonable and under the circumstances you will have to pay it, without the organizer being required to prove grounds for damage. This agreement does not impede the organizers from claiming a higher amount of compensation in accordance with the nature of the violation.

9. Art Installations and Art in the Temporary City

- 9.1. The Temporary City we are building is dedicated to total self-expression and art, including installations (an art installation is defined as any type of sculpture or art placed at the event), performances, Theme Camps, and unique costumes. This is the perfect place to give free reign to creativity and allow creation without restrictions and boundaries. The art created at the event is not commercial, is not commissioned and should not carry any branding.
- 9.2. If you are interested in setting up an art installation at the event, you will need to register and receive prior approval from the organizers and follow their instructions, please contact content@midburn.org.
- 9.3. Burning an art installation is only allowed with the prior approval of the organizers, and under their management.

10. Theme Camps

Theme Camps are an integral part of the fabric that creates the event. Unlike standard camps that are designed to provide existential services to their members (residence, food, etc.), a themed camp also provides a space that invites other participants to come and enjoy certain content activities (e.g., music, dances, workshops, relaxation space, creative space and so on). If you

intend to establish a Theme Camp, you will have to plan and consider every possible safety aspect in connection with it, it is your responsibility to take care of and bring with you everything necessary for setting up, dismantling, and maintaining the camp, in a safe and responsible manner, while preventing any risk to the participants and its guests.

11. Safety at the Event

- 11.1. **General safety is the top priority** - The organizers regard safety at the event as a supreme value and a fundamental and essential condition for the conduct of any event in general. Each participant bears full responsibility not to endanger any other person with their actions. You are required to "be vigilant" and stay alert to safety risks in your environment, act to prevent and/or remove them, and, if necessary, immediately alert the organizers about hazards.
- 11.2. **Personal safety** – First and foremost, take care of yourself! To remind you, you're setting up your temporary home in the desert, so it's essential to ensure sufficient water intake in these conditions. Be cautious of sun exposure, equip yourself with warm clothing for the cold nights, listen to your needs and your body's demands. Maintain your work safety during the setting up and dismantling of your camp. At night, ensure you and your surroundings are well-lit; be mindful of objects, pegs, ropes, and anything else that might pose a danger to your well-being.
- 11.3. **Tent/Camp Safety** – Setting up a camp or tent in the Temporary City may be accompanied by many safety risks, such as poles, stakes, large shade structures, other equipment brought or set up by you, use of work tools, electricity, gas, and fire, or other risk factors resulting from staying there. In addition, extreme conditions and strong winds in the Temporary City could blow away anything that is not securely fastened, posing further risks to safety. **It is imperative that you take all necessary measures to prevent these additional dangers.**
- 11.4. **Safety of Installations, Facilities, and Theme Camps** – Setting up and/or operating a theme camp or installation in the Temporary City may be accompanied by additional safety risks, such as but not limited to: falling, collapsing, electrocution, overcrowding, and any other risk arising from them. Therefore, if you are planning or participating in the setup of an installation, facility, or theme camp, it is your responsibility to ensure the setup, operation, maintenance, and dismantling of the installation, facility,

or theme camp safely and responsibly, while preventing any risk to you and other participants throughout the event. If you have received approval to set up an installation, facility, or theme camp in the Temporary City, you must act according to the organizers and their safety consultant's instructions, and full responsibility for its safety (including its establishment and dismantling) rests with you. The use or activity of any participant in an installation, facility, or performance that allows use or activity therein is **the sole responsibility of the participant**.

11.5. Fire Safety – it is strictly forbidden to light fire/bonfires, etc. in the territory of the Temporary City without the permission of the organizers. Permission to light fire, if it is granted by the organizers, will be done in a controlled manner under close supervision and using suitable apparatus (stainless steel fire barrel, steel barbecue, etc.).

11.6. Activity and Content Safety – If you conduct activities during the event that may pose any kind of danger, such as fire activities (e.g., juggling), circus and acrobatics, or any other dangerous activity, you are solely responsible for conducting this activity while fully ensuring your safety and the safety of the participants. If you choose to participate in a dangerous activity of any kind during the event, you do so at your own full responsibility. Also, if you conduct activities during the event that include sexual content, workshops, and/or any issue involving gender and sexuality, you are absolutely responsible for maintaining a safe space for participants.

If during the event you choose to participate in a dangerous activity of any kind, you do so solely at your own risk.

11.7. General Safety Rules – Throughout the event, you must act according to the safety instructions that will be distributed and published in connection with the event, and also obey any other and/or additional safety instructions as they are provided to you by the organizers in any way. Be aware, the organizers or their representatives may instruct you to correct, remove, or stop any safety hazard and reserve the right to take immediate action to correct or remove anything that constitutes a danger to public peace, and you shall have no claims in this regard. Furthermore, the event organizers have the right to charge you for expenses incurred in correcting or evacuating the safety hazard.

12. Living Conditions at the Event

Please note, a significant part of the events take place under the open sky, in various weather conditions, some of which can be extreme or harsh, and at

times even dust and sandstorms. As part of Midburn culture and the Ten Principles, there is a prohibition on commerce of any kind, so it will not be possible to purchase anything at the event. Therefore, you must take care of yourself as necessary for your survival, well-being, and health maintenance throughout the event, all according to the event's conditions, location, and season.

13. Volunteering and Participation

As part of our community values, we encourage community effort and participation. The fundamental assumption is that joint creation fosters human connection and community partnership. Participation is an integral part of the event experience, and the participants are the ones who build the temporary city, operate it, and ultimately take care to dismantle it. To participate in the construction and operation of the city, you must register through the designated link on the Midburn website, and according to need, you will be contacted by the various departments. During the event, there may be an additional requirement to participate in various roles; if you wish to participate during the event, you can go to the temporary city's center and register there.

Please note that your volunteering activity throughout the event is not covered by the Israeli National Insurance Law.

14. Medical Treatment During The Event

As a rule, we recommend that during your stay in the Temporary City you are covered with the appropriate health insurance for your event participation. A volunteer clinic will be operated in the Temporary City, the purpose of which is to provide medical assistance to those attending the event, in addition to the medical insurance required by the licensing regulations.

If you do need medical treatment, you can choose to accept medical attention from the Event clinic's voluntary medical staff, or to seek alternative medical treatment, outside of the Temporary City. **If you choose to accept treatment/advice from the event's clinic, all treatment/advice offered by the clinic's volunteers and the event organizers is void from any grievances at a later stage, whatever the outcome.**

15. Risk Awareness, Waiver and Release

15.1. Risks at The Event - the event organizers will do everything in their power to manage all safety aspects of the event in accordance with the licensing conditions and the national law. However, taking into consideration the large number of participants and possible risks, by purchasing a ticket to

the event and participating in it, you confirm your understanding and knowledge that you may take part, either as a spectator, as a participant, or as a bystander, in activities that may involve the risk of injury, disability, death, loss of property or any other damage, which may be caused by as a result of any of the factors below or a combination of them:

15.1.1. Actions or lack thereof, errors and innocent mistakes made by the organizers, volunteers, and other participants.

15.1.2. The conditions and limitations of the event, including the equipment in use.

15.1.3. Weather and temperature conditions.

15.1.4. The state of the other participants.

15.1.5. Other unforeseeable risks.

15.2. Waiver and Release - in view of the above, by purchasing a ticket and using it to enter the Temporary City, and/or actively participating in the event in any way, you commit and declare on your behalf, and on the behalf of anyone under your responsibility such as underaged minors, the following:

15.2.1. I am solely responsible for all that may happen to me during the event or due to participating in it.

15.2.2. I understand and acknowledge the event will feature works of art, installations, theme camps, events and performances, which are not under the responsibility or ownership of the organizers and therefore I am aware of and knowingly undertake all risks that can be associated with my participation in any manner.

15.2.3. I release the organizers and all those acting on their behalf of any responsibility for damages caused to me or my possessions during the event.

15.2.4. I will undertake to indemnify the organizers, their agents, or third parties for any expense incurred to them due to damages caused by me during The Event, because of the risks listed above.

16. Exclusion from Association Events

16.1. It is clarified and agreed that the Midburn Association reserves the right to deny entry, immediately remove from the event, ban from future events, or permanently ban from all events, to any person who does not act in accordance with the regulations, terms and conditions of the organizers. This includes those who are reported or suspected of engaging in violence and/or sexual violence and/or sexual harassment and/or who is found to

have entered an association event fraudulently, without a permit and/or who does not have an entry ticket that matches their identification card or does not have a bracelet that correctly verifies the purchase of a ticket in their name.

16.2. If you violate any of these conditions during an event in which you are participating, the event organizer will be entitled to act towards you according to its absolute discretion in one or more of the following ways, without any liability to you because of this:

16.2.1. To terminate your participation in the event and immediately remove you from the event area.

16.2.2. To demand that you rectify the violation/damage caused by you and all that implies.

16.2.3. To prohibit and prevent your participation in any other event, for a defined period or indefinitely, and/or to freeze or cancel your registration as a profile owner on the website and/or of the association.

16.3. It is clarified and agreed that Midburn reserves the right to immediately confiscate equipment which, according to the discretion of the organizers, its use causes a violation of the organizers' instructions and/or of these regulations, and the user will have no complaint and/or objection and/or demand towards the organizers because of this.

16.4. The Midburn Association and/or anyone on its behalf will not financially reimburse anyone removed from the event, including the cost of the entry ticket, or any damages claimed due to removal from the event and/or for the confiscation of equipment.

17. General

17.1. You hereby authorize the organizers to contact you via the email address you provided when registering for the association's activities/updating your profile on the association's website. This includes updates, changes, and additions to these terms, which will apply to you upon their mailing as stated, and you commit to keep updated with and adhere to them. The provisions of these terms will also apply to updates mailed to you as mentioned.

17.2. The local jurisdiction for all legal matters concerning this Event will be the Tel-Aviv District Court.

18. Confirmation

- 18.1.** It is clarified and agreed that purchasing a ticket to the event and/or entering the event area constitutes my confirmation that I am over 18 years of age, I am legally competent to perform legal actions, I have read and understood the terms of these regulations, I commit to comply fully with its terms, and that I waive any claim of not knowing the regulations and all its conditions.
- 18.2.** If my children accompany me to the event, I confirm, as their legal guardian, to comply with everything stated herein in the terms and conditions regarding minors and agree on their behalf to their full compliance.
- 18.3.** I confirm the receipt of mail and/or communication from Midburn and/or its representatives.
- 18.4.** I am aware and it is clear to me that without my agreement to be bound by these terms as stated, the organizers would not agree to my participation in the event initially.
